

#### Q9: WHEN WILL BE THE BB STARTS TO REQUIRE THE UTILIZATION OF THIS NEW FMEA?

A9: There is no specific answer for now BUT the IATF and the oversight offices have an action item to update the auditor

development program (ADP) for the new FMEA. The oversight offices will work with AIAG and VDA to get their staff trained and update the ADP module and oversight will communicate through the CB to all the auditor and specifically give them 6 month for auditor to take the online training and be able to pass the test and the IATF oversight office will track that completion and they typically give themselves at least 80% of the auditor went through this before we aspect that start recurring in field. Since the ADP has yet to be updated, the earliest could be mid of 2020. However if your new program or if there is any agreement between you and your customer to have the new FMEA rolling, the expectation for compliance is immediately.


